<ul style="list-style-type: none"> <li>▪ Alcohol-impaired driving</li> <li>▪ Having a Blood Alcohol Concentration (BAC) at or over 80mg per 100ml of blood within 2 hours of driving</li> </ul>			
<ul style="list-style-type: none"> <li>▪ Drug-impaired driving</li> <li>▪ Having 5ng or more of THC per ml of blood within 2 hours of driving</li> <li>▪ Any detectable level of LSD, psilocybin, psilocin, ketamine, PCP, cocaine, methamphetamine, 6-mam within 2 hours of driving</li> <li>▪ Having 5mg or more of GHB per 1 liter of blood within 2 hours of driving</li> </ul>	<p><b>Mandatory minimum:</b> \$1000 fine 1 year driving prohibition</p> <p><b>Maximum:</b> 10 years imprisonment 3 years driving prohibition</p>	<p><b>Mandatory minimum:</b> 30 days imprisonment 2 years driving prohibition</p> <p><b>Maximum:</b> 10 years imprisonment 10 years driving prohibition</p>	<p><b>Mandatory minimum:</b> 120 days imprisonment 3 years driving prohibition</p> <p><b>Maximum:</b> 10 years imprisonment Lifetime driving prohibition</p>
<p><b>Combination</b> Having a BAC of 50mg per 100ml of blood + 2.5ng or more of THC per 1ml of blood within 2 hours of driving</p>			
<p><b>Refusal to comply with demand for sample</b></p>	<p><b>Minimum:</b> \$2000 fine</p>		
<p><b>Drug-impaired driving – Summary conviction</b> Having over 2ng but less than 5ng of THC per ml of blood within 2 hours of driving</p>	<p><b>Maximum:</b> \$1000 fine</p>		
<p><b>Impaired driving causing bodily harm</b></p>	<ul style="list-style-type: none"> <li>• <b>Summary conviction:</b> Maximum 2 years imprisonment less a day</li> <li>• <b>Indictment:</b> Maximum 14 years imprisonment</li> </ul>		
<p><b>Impaired driving causing death</b></p>	<p><b>Indictment:</b> Maximum life imprisonment</p>		
<p><b>First offence + BAC of 80-119mg</b></p>	<p><b>Mandatory minimum:</b> \$1000 fine</p>		
<p><b>First offence + BAC of 120-159 mg</b></p>	<p><b>Mandatory minimum:</b> \$1500 fine</p>		
<p><b>First offence + BAC of 160mg or more</b></p>	<p><b>Mandatory minimum:</b> \$2000 fine</p>
